KFC Game Day Bucket Promotion

Terms & Conditions

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. The promotion is open to New Zealand residents aged 18 and over. Employees of the Promoter and any agency involved with this promotion, and the immediate families of such employees, are not eligible to enter.
3. The promotion commences at **9am** on Saturday 7th September 2019 and finishes at **9am** on Wednesday 30th October 2019 (**'Promotion Period'**).

How to Enter the KFC Game Day Bucket Promotion:

4. To enter the promotion, simply enter your details at www.gamebucket.co.nz including your first and last name, email address, phone number, address and the Game for which you would like to win the Prize, during the Promotion Period.

Prize Details

5. There are ten prizes of a KFC Game Day Bucket, valued at NZD**\$350.00** RRP, to be won (**'Prize'**).
6. The Prize includes:
 - a. KFC catering for 10 people (valued to a maximum of \$120.00 RRP);
 - b. KFC Merchandise (to be determined by KFC in its sole discretion); and
 - c. Delivery of the Prize to the address nominated by the winner.

Prize Draw and Acceptance

7. The Prize winners will be drawn by the Promoter, in accordance with clause 8, on the following dates –
 - a. Week 1 – Draw 1 winner by 9am 17th September 2019 for games played from 20th September – 26th September.
 - b. Week 2 – Draw 1 winner by 9am 24th September 2019 for games played from 28th September – 4th October
 - c. Week 3 – Draw 2x winners by 9am 1st October 2019 for games played from 5th October – 13th October
 - d. Week 4 – Draw 2x winners by 9am 8th October 2019 for games played from 5th October – 13th October
 - e. Week 5 – Draw 2x winners by 9am 15th October 2019 for games played from 19th October – 27th October
 - f. Week 6 – Draw 2x winners by 22nd October 2019 for games played from 1st November – 2nd November

8. The winners will be the first entry or entries (as applicable) randomly drawn from all entries received by the promoter between 9am on Saturday 7 September and 9am on the date of the relevant draw.
9. Prize winners will be contacted by the Promoter via the phone number and email address provided at their time of entry into the Promotion.
10. Within 24 hours of being contacted by the Promoter, winners must:
 - a. confirm acceptance of their Prize;
 - b. nominate a residential New Zealand address for delivery of their Prize ('**Delivery Address**'); and
 - c. nominate a date and time on which they would like to receive their Prize ('**Delivery Date**').
11. If a winner does not confirm acceptance of their Prize, or provide the information required at clause 10, within 24 hours of being contacted by the Promoter, their Prize will be forfeit, and the Promoter may draw a new winner on the same terms as the original prize draw.
12. The Delivery Address must be within 10 kilometres of a KFC restaurant.
13. The Delivery time must be between 1pm – 9pm NZ time.

General:

14. The Prize is not transferable, changeable or redeemable for cash.
15. In the event that the Prize, or any part of the Prize, becomes unavailable for any reason beyond the Promoter's control, the Prize, or that part of the Prize, will be void, and no compensation will be payable.

Neither the Promoter nor any other entity associated with this competition will be responsible for any late, lost, misdirected or incorrectly submitted entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received by the Promoter, not the time the entry is submitted by an entrant.
17. The Promoter reserves the right to disallow entries in its absolute discretion and without giving reasons.

The Promoter reserves the right, at any time, to verify the validity of claims and determine the eligibility of entrants (including an entrant's identity) and to disqualify any entry or refuse to award a Prize where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.

The ensuing copyright will rest with the Promoter, without any claim to compensation from the entrants.
